General

These conditions apply to the following 2025 European Championship organized by Formula Karting:

- European Championship Outdoor Rental Karting 2025

Thank you for participating in the European Championship Outdoor Rental Karting 2025.

As a participant you contribute to the great mission of Formula Karting to make racing as a sport more accessible and to stimulate talent within the racing sport.

1) Sign up requirements

- 1.1 No license is required.
- 1.2 For the race in Ostricourt, the minimum age is 13 with significant karting experience.
- 1.3 Based on recent race experience, a driver may request dispensation (proof should be provided).
- 1.4 There will be a minimum race weight requirement of 85 kilos per participant (drivers weight plus gear and extra weight).

2) Liability and damage

- 2.1 Participation is entirely at own risk or the risk of your parent/guardian if the participant is younger than 18 years old.
- 2.2 Spectators watch at their own risk. Children must be supervised by an adult at all times.
- 2.3 Formula Karting cannot be held liable for any accidents or injuries during racing activities.
- 2.4 Formula Karting reserves the right to refuse access to the race location to anyone who may be a risk to the safety of themselves or anyone else on the premises.
- 2.5 On the first day of racing, the competitor will sign an entry form confirming the waiver.

3) Medical condition

- 3.1 Your height is between 150 and 200 centimeters and your weight is below 120 kilos.
- 3.2 You have no medical condition that would hinder you from safely driving the races.
- 3.3 You have told us that you have no other medical conditions of concern, so that we can advise you if the races are suitable for you. These include, but are not limited to: heart disease, back injury, epilepsy, amputations, artificial limbs, hearing or visual impairment, or any form of mental or physical disability.
- 3.4 Participation when you are pregnant is not allowed.

4) Behavior and compliance with rules

- 4.1 During the race days, the driver is obliged to adhere to the safety briefing and Formula Karting Sporting Regulations 2025 received in advance, in which the established rules and guidelines.
- 4.2 These rules and guidelines also apply to the driver's guidance (family, friends, etc.).
- 4.3 Failure to comply with these rules will result in disqualification of the driver.
- 4.4 In the event of disqualification from a race day, no refund of entry fee will be made.
- 4.5 The organization reserves the right to shorten, end or remove sessions from the daily program.

Season

- 5.1 A** A registration fee of €150 applies to registration for the entire season (3 races), which consists of a deposit of €50 per raceday. This will be deducted from the day amount €249 - €50 = €199. The deposit must be credited to the IBAN number of Formula Karting no later than 10 working days after confirmation of the registration.
- 5.1 B** Before each raceday, the driver must ensure that the remaining amount €199 is credited to Formula Karting's bank account no later than 14 days before each raceday.
- 5.1 C** An invoice can only be requested for the complete seasonal payment of €747. Consisting of 3 x €249. The payment must be credited to the IBAN number of Formula Karting no later than 10 working days after confirmation of the registration.
- 5.1 D** After receipt of your payment, and confirmed by the organization your registration will be final for the entire season.

Single race days

- 5.2 A** The registration fee for a single race is €249, and must be paid within 5 working days after registration confirmation and credited to the IBAN number Formula Karting.
- 5.2 B** After receipt of your payment, and confirmed by the organization your registration will be final for the race.

General

- 5.3 A** If payments are not credited within the term, Formula Karting reserves the right to remove the participant from the list and give the spot to someone else.
- 5.3 B** The person who makes the payment is responsible for correctly stating the details of the reservation.
- 5.3 C** The payment is also a confirmation that you have read and agreed to the Terms and Conditions.
- 5.3 D** All seasonal drivers that pay the deposit or full season before January 10 2025 will receive a goody bag (including the EC 2025 T-shirt, sunglasses, visorsticker...).
- 5.3 E** If an invoice is requested for a single raceday or practice heats, there will be a surcharge of €10 (administrative cost) per invoice.
- 5.3 F** All prices quoted include VAT.

6) Sign out and refunds

- 6.1** If a driver cancels up to ten days before a race day, the entry fee of the race minus €50 will be refunded to his or her account. The €50 can not be transferred as credit for future races.
- 6.2** If a driver cancels within ten days before a race day, the entry fee of the race minus €100 will be refunded to his or her account. The €100 can not be transferred as credit for future races.
- 6.3** If a driver does not cancel, there will be no refund of the entry fee. The entry fee can not be transferred as credit for future races.
- 6.4** If a driver has a well-founded demonstrable reason for canceling (such as a funeral), the refund will be considered on a case-by-case basis. Formula Karting may ask for proof.

7) Prizes

- 7.1** The champion of the European Championship receives a Tillotson T4 Kart, model 2025, that raced one race at the T4 Nations Cup 2025. The kart will then be completely checked by Schuurman B.V. and be ready to give to the champion in January 2026

8) Privacy / Social media

- 8.1** When participating in the European Championship, the driver, or in the case of minors, the parent/guardian, agrees to the use of photo and film recordings for promotional purposes (posters, flyers, banners, etc.).
- 8.2** The driver also agrees to the use of photo and film recordings for the Formula Karting websites and various social media platforms (Facebook, Twitter, Instagram, TikTok etc...).
- 8.3** No rights can be derived from the photo and film recordings.
- 8.4** The mobile phone number of the participant or supervisor/guardian can be added to the WhatsApp group for unilateral information sharing. If not desired, the participant or supervisor/guardian is free to sign out.
- 8.5** If a participant, team or supervisor/guardian does not want to give permission, this must be communicated in writing to the organization before paying the season deposit or single race day.
- 8.6** All personal information provided by the driver or guide/guardian remains with the organization and will therefore not be made available to third parties.
- 8.7** Insulting or attacking drivers, marshals, race directors and or the organization on social media can lead to exclusion from all events organized by Formula Karting. This applies to drivers, parents, coaches and supervisors. Behavior of parents and supervisors can also lead to exclusion of the driver, without refund of entry fee.
