#### 1 REGULATION:

The competitions will take place in support of the rules for Snowkite competitions implemented in part by the CKWI, referring to the SnowKite Tour, the notice of race, the competition instructions, the specific rules for each discipline (NoRSI). RRS appendix F.

The race committee will give all the information regarding the format and will illustrate the race instructions, safety regulations, race procedures during the riders meeting and through subsequent communications that will be posted on the appropriate official press release panel as specified above.

#### **2 DISCIPLINES AND CATEGORIES:**

The disciplines foreseen for the championship will be Racing, Race cross, Long Distance. The categories will be ski and snowboard both in the KITE and in the WING section. The classes will be Men & Women U19 Boys & U19 Girls (since 2004) (>11years)

#### 3 ADMISSION:

Admission is free and there is no limitation to the number of members. All competitors must have signed the registration for the race and be in possession of a type B competitive medical examination, FIV card and CKWI Class card. Foreign athletes must be in compliance with their respective National Association rules. Underage competitors must deliver the registration form signed at the bottom by the parent, guardian or "Support person" who during the event assumes the responsibility of making them. Everyone must be in possession of an RCT policy including Kiteboarding with a minimum coverage of € 1,500,000.00 (one million five hundred- thousand // 00)

# **5 CLASSIFICATION AND SCORING SYSTEM:** Classification of categories and disciplines

#### **CAMPIONATO ITALIANO for SnowKite RACE disciplines.**

- men and women SnowKite Ski
- men and women SnowKite SnowBoard

#### International SNOWKITE OPEN for SnowWING RACE disciplines.

- men and women SnowWing (Ski & SnowBoard a same class)

#### International SNOWKITE OPEN for Snowkite LONG DISTANCE disciplines.

- men and women SnowKite Ski
- men and women SnowKite SnowBoard

For the stage of the Italian championship, the scoring system provided in point 13 will be applied, together with the next stage of the Italian championship to determine the overall classification.

The score of all the classifications of the event will be from App. A. The following differences will be applied: from 1 to 3 trials no difference; from 4 to 6 tests 1 discard; from 7 tests up 2 discard.

The event will be considered valid if at least one race is completed; the event will be considered valid for the purposes of the national classification.

If the Resia race is not held, each competitor duly registered and present will be assigned a score equal to the average of all the points that would have been assigned in this event of Resia rounded to the higher 0.5. For the purpose of the national ranking, all the Italian events of the Championship will be taken into consideration, Resia and Roccaraso with the absolute racing and long distance classification. A competitor who does not participate in the event of Resia will not receive points, even if he is regularly registered with payment made online but not present. In the case of a tie in the ranking, this will be dissolved in favor of the competitor who has the best gap. The rankings of all categories will be extrapolated from the general ranking; The trophies of the men and women Resia event will be awarded to the winners of their respective rankings only if at least 3 competitors are registered.

#### 6 COURSE:

The event will take place in the area used for the practice of Snowkite.

Up & Downwind course will preferably be prepared. The choice of the course and the characteristics of the start and finish are at the discretion of the Race Committee, depending on the weather conditions and cannot be subject to protests or requests for repairs. Possible courses can be found in Addendum - NoRSI. Long Distance: competitors will be classified in order of completed laps and, within the same number of laps completed, in order of arrival. Competitors with the most completed laps will be ranked first, competitors with the second most completed laps will be ranked second, etc.

#### **8 REGISTRATION:**

All registrations must be completed and paid online and completed at the regatta secretariats as per the notice published by the individual organizing clubs.

At the end of the time indicated in the notice of race of the single stage, these will be strictly closed, regardless of the causes of the delay, whether personal or force majeure or whether or not he has promptly notified. It is strictly forbidden to have colleagues, friends or third parties confirming attendance. Nor will it be allowed to transfer, for any reason, the registration fee from one member to another or from one regatta to the next. To facilitate the organizational task and to contain costs, it is strongly recommended to register with sufficient notice.

#### 9 MEDIA:

By registering for a regatta, competitors automatically grant full right and permission to the Organizing Body to create, use and show, on any occasion and at their discretion, any audio recording, photographic image, film, video and TV recording. live or recorded, carried out during the event in which it takes part, without any compensation.

#### **10 SUPPORT PERSONS:**

Accredited support persons / coaches must follow the guidelines specified during the riders meeting.

#### 12 RESPONSIBILITY:

As per the fundamental rule, the participants in the regatta referred to in this regulation take part under their full and exclusive responsibility, the competitors and their support persons are solely responsible for the decision to take part or continue the regatta. The Kiteboarding Italia Class, the Organizing Committee, the Race Committee and the Jury and those who for whatever reason take part in the organization decline any and all responsibility for damages that people and / or things may suffer, both on land and in the field, in consequence of their participation in the regatta referred to in this notice of race. It is the competence of the competitors and their support people to decide on the basis of their abilities, the strength of the wind, the state of the race field, the weather forecast and everything else that must be expected by a good athlete, whether to participate in the regatta, to continue it or to give up.





# **15 PROTESTS, SANCTIONS AND REQUESTS**

For each fleet / group / division, the protest time limit is 30 minutes after the last competitor has finished the last race of the day for that fleet / group / division, or when AP is displayed on A or N on A.

#### **16 RISK STATEMENT**

- 16.1. In cases of force majeure or on grounds of administrative orders or for safety reasons, the organizing authority is entitled to make changes in the realization of the event or to cancel the event. This does not constitute any liability by the organizer towards the participant, if the reasons for the changes or the cancellation do not result from a willful or grossly negligent behavior of the organizer.
- 16.2 In case of a violation of obligations that do not constitute primary or material contractual duties (cardinal obligations), the liability of the organizer for financial and property damages incurred by the participant during or in connection with the participation in the event and resulting from a conduct of the organizer, CKI, the involved classes and their representatives, servants or agents (including but not limited to race committee , protest committee and technical committee), is restricted to damages that were caused willfully or grossly negligent. When a violation of cardinal obligations occurs due to minor negligence, the liability of the organizer is limited to foreseeable, typical damages.
- 16.3 Competitors and support team participate in the event entirely at their own risk and they are reminded of the provisions of RRS 3, Decision to Race. Kiteboarding is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
  - They acknowledge that there are risks involved in the Event. They fully realise the dangers of
    participating in the Event, and fully assume the risks associated with their participation and
    their wellbeing and safety during and after the Event.
  - They understand and acknowledge that the Event organisers (including all officials and event volunteers) provide no warranties, regarding their wellbeing and safety.
  - They acknowledge that participating in this event may involve a test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by the elements, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, lack of hydration, and actions of other people including, but not limited to, participants, volunteers, officials, and/or producers of the event.
  - They agree that to the extent permissible by law, World Sailing, CKI, their classes, the event organisers (including all officials and event volunteers), CKI, the sponsors and other parties associated with the Event, have no liability to them whatsoever for any direct or indirect loss, (including, but not limited to injury or death) sustained by them during or in any way related to their participation in the Event.
  - They WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for their death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to them including their traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: World Sailing, CKI, their classes, the event organisers (including all officials and event volunteers), CKI, the sponsors and other parties associated with the Event, employees, volunteers, representatives, and agents, and the event holders, sponsors, and volunteers;
  - They INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons
    mentioned in the above paragraphs from any and all liabilities or claims made as a result of
    participation in this event, whether caused by the negligence of release or otherwise.
  - They have taken medical advice on any pre-existing medical conditions and confirm that it is medically safe for them to participate in the Event.
  - They are responsible for the safety of themselves, their equipment and their other property at any time.







- They are satisfied that their equipment is in good order, equipped to compete in the event and they are fit to participate;
- They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- They consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this event.
- They acknowledge that the provision of a race management and rescue team, judges, umpires
  and other officials and volunteers by the organizer does not relieve them of their own
  responsibilities;
- They acknowledge that the provision of rescue craft cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

#### 17 DATA PROTECTION AND PRIVACY

With registration the competitor or support person agrees on data usage as defined in this data protection and privacy notice. See CKI Privacy Notice in Addendum 6.

Reference is made to data protection of personal information and data. Any personal information and data given to the organizers will be used only as follows:

- (a) All data regarding participating athletes, coaches and their kiteboard will be processed and archived for the purpose of this event and events of similar nature that might be of interest to the participant.
- (b) Personal information contains the participant's real name, date of birth, home club, boat type. boat number, address data, mobile phone, email address and emergency contact information. In particular, results, calculatory and visual analyses, position monitoring and race analyses will be published with reference to the competitors' names.
