

USER'S MANUAL—RACING SHOES FIA 8856-2018

The **Marco Massetti** product as well as the materials used for packaging are homologated by the International Automobile Federation according to the FIA 8856-2018 standard. For the full list of materials used, please read the illustrative label.

1. HOMOLOGATION: The FIA homologation label is in a prominent position on the outer surface of both shoes. In correspondence to it, the FIA hologram is sewn on the inside. The user is advised that removal and/or alteration of the homologation and/or hologram will void the warranty and invalidate the homologation.

2. WASHING AND MAINTENANCE RULES: Garments should be washed according to the instructions indicated on the label attached to the garment. To maintain the qualities and characteristics of the purchased product for a long time, the following care instructions should be followed. In case of stains, rub gently with a sponge soaked in warm water, without using solvents. Do not machine wash. Dry the shoes at room temperature, away from heat sources and sun exposure that can deteriorate the color. Drying in a tumble dryer is prohibited.

INSTRUCTIONS FOR THE CORRECT USE OF THE GARMENT: Before use, check the integrity of the Product by verifying that it is not damaged so that the level of protection offered by the garment does not diminish. An appropriate garment for your size is recommended so as to allow free movement. An improperly sized or improperly worn shoe offers reduced protection. **Marco Massetti S.r.l. is not liable for damages resulting from lack of and/or improper maintenance, abuse and misuse towards users and/or third parties.**

6. INTENDED USE: The intended use of this garment is specifically for motoring. Any other use as a protective garment is expressly prohibited. This garment cannot protect against all possible hazards it may incur during motor racing and cannot provide complete or unlimited protection against injury, death, or damage resulting from accident, collision, impact, loss of control, or the like. This garment as a whole protects against fire and heat transmission from flame for a limited period of time and, in any case, cannot offer complete protection against any source of heat or fire. Each assembly that makes up the is tested to **ISO 9001:2015** (ISO 9151 and ISO 15025) according to the FIA 8856-2018 standard. Because of their vulnerability, the neck, wrists and ankles must be covered by at least two protective garments. To achieve the highest degree of protection needed use all clothing required in **Appendix L (Chapter III, Article 2)** to the FIA International Sporting Code.

Protective clothing is not able to protect against all the possible hazards which might be encountered in automobile racing. The clothing approved according to standard 8856-2018 is designed to provide protection against heat and flame.

Sizing and usage Users shall ensure that garments are not too tight, as this reduces the level of protection, and that they are comfortable to wear under the that they are comfortable to wear under the actual conditions of use.

In order to obtain maximum protection, all the clothing requested in Appendix L (Chapter III, Article 2) to the FIA International Sporting Code should be used. Wearers are warned of the particular vulnerability of the neck, wrists and ankles. The neck, wrists and ankles shall always be covered by at least two articles of protective clothing.

Undergarment and balaclava The balaclava and top underwear shall overlap by a minimum of 3 cm around the driver's neck, except at the front central line where they shall overlap by at least 8 cm. The top and bottom underwear shall overlap by a minimum of 7 cm around the drivers waist.

Addition of advertising: Embroidery sewn directly onto the garments shall be stitched onto the outermost layer only. The backing material of badges shall be flameproof and in conformity with standard ISO 15025. Thread used to affix the badge to the garment shall be flameproof

and in conformity with standard ISO 15025. It is also recommended that the embroidery thread on badges is flameproof and in conformity with standard ISO 15025. When affixing badges and signs to the garments, heat bonding shall not be used. Only the garment manufacturer can use printing or transfers for adding advertising onto the garment. It is necessary to have a certificate from the manufacturer for any garment customised using printing or transfers. The garment shall not be cut or perforated. **FIB:** any advertising or customisation not complying with these conditions will result in the invalidation of the homologation of the garment concerned. The use of garments with invalid homologation during an event may result in penalties for the driver, or even in disqualification from the event.

IN CASE OF DOUBT ABOUT THE ADDITION OF ADVERTISING, IT IS RECOMMENDED TO CONTACT THE MANUFACTURER.

7. PRODUCT INFORMATION: This is a fire protective garment, in case of damage (e.g. tears, punctures, contact with fire, etc.) the shoe must be replaced. Marco Massetti S.r.l. accepts no responsibility for shoes that have undergone alterations (including embroidery and decorations) and/or repairs not specifically approved in writing or made directly by **Marco Massetti S.r.l.** Embroideries should be sewn only on the outer layer to ensure proper thermal insulation. Backing materials for embroidered labels must be flame resistant in accordance with ISO 15025 so as not to affect, in the event of combustion, the efficiency of the shoe. Threads used for stitching embroidered labels must be flame resistant and in accordance with ISO 15025 and also recommended that threads used for embroidery be flame resistant in accordance with ISO 15025. In the case of patch or logo additions, heat bonding is not allowed. In case embroidered or transfer labels are applied after the shoe is manufactured, the shoe must not be cut. Only the manufacturer may add printing and personalization to the product. It is necessary to possess the customization certificate issued by the manufacturer in case of customized products. The garment may not be cut or perforated.

N.B. any non-compliant embroidery will result in the revocation of the approval of the shoe under consideration, and its user may be excluded, by the responsible authority, of the event during which the infraction was detected. Alterations or modifications to the product will void the warranty and increase the risk of injury. **Marco Massetti S.r.l.** shall not be liable to the user in all cases in which the modification of the product has resulted in a reduction of the initial protection offered to the user, and excludes all liability of **Marco Massetti S.r.l.** to the user. In case of doubts about the possibility of the addition of prints or customizations, it is advisable to contact the manufacturer.

MARCO MASSETTI S.r.l. DECLINES ANY RESPONSIBILITY FOR DEATH OR INJURY SUFFERED BY THOSE WEARING ITS PRODUCTS.

8. INFORMATION REGARDING END-OF-LIFE GARMENT DISPOSAL: If the garments have not been contaminated with special substances or products, they can be disposed of as normal textile waste; if not, they must be disposed of in accordance with current legislative performance for special waste.

9. ADVICE IN CASE OF ALLERGIES: People who have skin allergies to certain materials should carefully monitor their skin each time they wear the garment. If irritation occurs, stop wearing the garment immediately and consult a doctor.

10. WARRANTY: Marco Massetti S.r.l. shoes are guaranteed for a period of 24 months from purchase (*). The warranty consists of free replacement or repair of the shoe upon notification of a manufacturing defect within 2 months of discovery. The warranty does not operate in the case of improper use of the shoes, in the case of washing and/or maintenance not confor- mended in accordance with the requirements of this manual and the labels sewn on the garment. As required by law, the warranty is provided directly by the **Marco Massetti S.r.l.** Retailer where the shoes were purchased, to whom we invite you to contact for any relevant needs. The user must verify at the time of purchase the presence of the FIA homologation labels and hologram. No warranty is given on garments lacking these acknowledgements.
